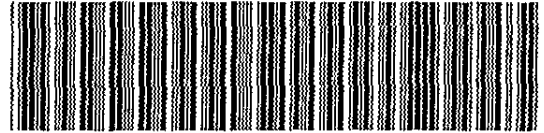

**ARTICLES OF INCORPORATION
OF**

FLATWOODS CAMO, INC.

The undersigned, acting as the Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE ONE

NAME AND ADDRESS

1.01. The name of the Corporation is Flatwoods Camo, Inc., and the address of its principal place of business is 4191 7th Avenue S.W., Naples, Florida 34119 and its mailing address is 6017 Pine Ridge Road, #142, Naples, Florida 34119.

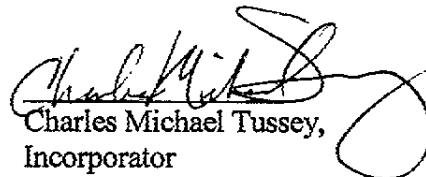
