

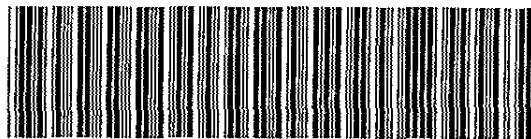

Articles of Incorporation
U.S. Tax Recovery Service, Inc.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be: **U.S. Tax Recovery Service, Inc.** (the "Corporation").

ARTICLE II

The principal place of business of this Corporation shall be: 617-A Cleveland Street, Suite #9, Clearwater, Florida 33755.

ARTICLE III
