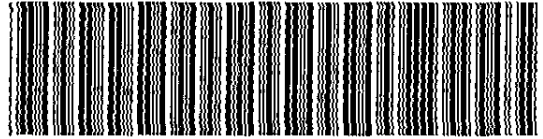

The name of this corporation is J. T. LEASING SERVICES, INC.




