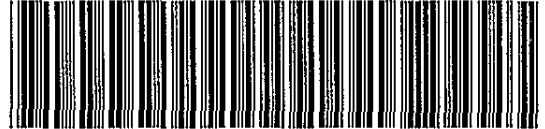

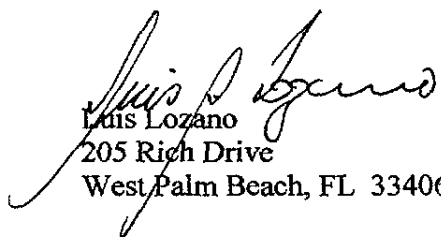

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing Business Corporation.

The name of the Corporation is GALAXY STONE, GENERAL CONSTRUCTION & REMODELING, INC.

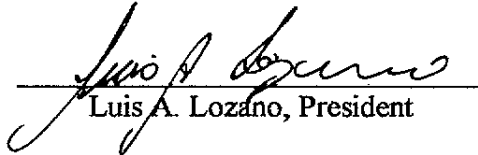

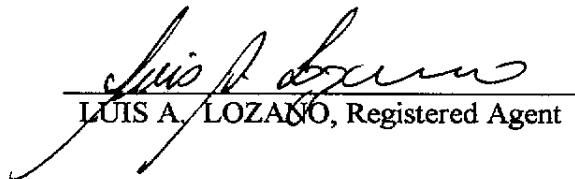
