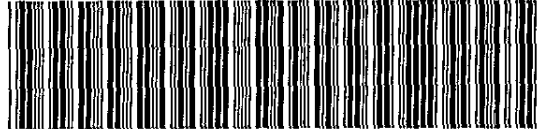



CAPITAL



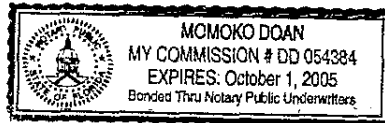
