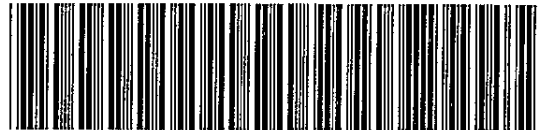

The name of this corporation shall be: **Bruce's Mobile Car Care, Inc.**

ARTICLE TWO (II) PRINCIPAL OFFICE
