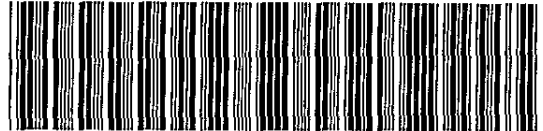

## **ARTICLE OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

### **ARTICLE ONE**

#### **NAME**

The corporation's legal name shall be Star-Tree International, Inc.

### **ARTICLE TWO**

#### **CORPORATE DURATION**

The duration of the corporation is perpetual.

### **ARTICLE THREE**

#### **PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:

1. To engage in the business of import and distribution of Chinese traditional herbal medicine, dry foods, outdoor furniture and pre-fabricated or custom-designed construction materials;
2. To engage in any other import any other products not mentioned in Item 1 from China to the United States and export products, technology and services from the United States to China consistent with international trade practice and American law and regulation on import and export business administration;
3. To do such other things authorized by law as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

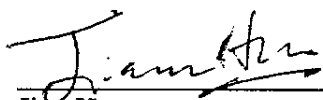

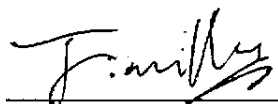
