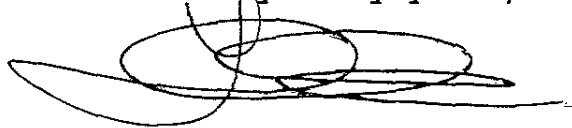

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is Pensacola Research Consultants, Inc.

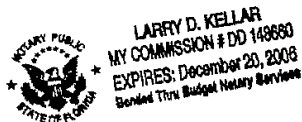
