



Articles of Incorporation J & B Medical Sales, Inc.

ARTICLE I NAME

The name of the Corporation is J & B Medical Sales, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal office and mailing address of the Corporation shall be 210 Ring Ave., NE, Suite 104, Palm Bay, FL 32909.

ARTICLE III

PURPOSE OF CORPORATION

The purposes for which the business of this Corporation shall be conducted are as follows:

- A. To engage in every phase and aspect of the business as determined by the Board of Directors from time to time including, without limitation, the manufacture, design, construction, ownership, use, purchase, sale or lease, of articles and property of all kinds and to render services of all kinds, and to engage in any lawful act or activity for which corporations may be organized under the laws of the United States and the State of Florida.

The Board of Directors of the Corporation may authorize, from time to time, the issuance of shares of common stock for such consideration as the Board of Directors may deem advisable, subject to such restrictions or limitations, if any, as may be set forth in these Articles of Incorporation, as amended, or the Bylaws of the Corporation.

ARTICLE VI VOTING RIGHTS

Except as otherwise provided by law, the entire power for the election of Directors, and for all other purposes, shall be vested exclusively in the holders of the outstanding shares of common stock.

ARTICLE VII REGISTERED AGENT

The initial Registered Agent of the Corporation shall be Jesse Rhoden whose business office is identical with the Corporation's registered office set forth below.
