ARTICLES OF INCORPORATION
OF
STONE NORTH AMERICA CORP.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is **STONE NORTH AMERICA CORP.**

ARTICLE II

The existence of the Corporation shall begin on September 11, 2003.

ARTICLE III

The street address of the principal office of the Corporation is 212 Three Islands Blvd., #105, Hallandale, FL 33009

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 500, par value \$0.01 per share, all of which shall be Common Shares. 


