ARTICLES OF INCORPORATION

OF

W & R Realty Investments Inc.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

Name and Address

The number of directors and/or officers may be either increased or diminished from time to time by the By-Laws, but shall never be less than one. By-Laws

The power to adopt, alter, amend, or repeal By-Laws shall be vested in the Board of Directors and the shareholders.
