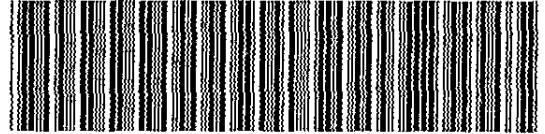

**FIRST:** The name of the Corporation is **" OMSHRI ENTERPRISES, INCORPORATED."**

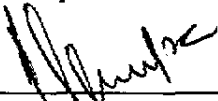
