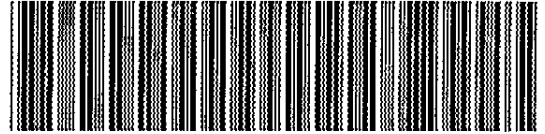

OF

ARTICLE I--NAME

The name of this corporation is LAWTON AUTO SERVICE, INC.

ARTICLE II--DURATION

This corporation shall exist perpetually.

ARTICLE III--PURPOSE

The power to adopt, amend or repeal bylaws of this corporation shall be vested in the members.

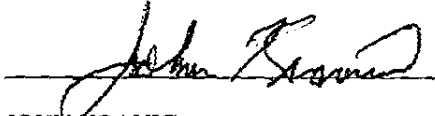
ARTICLE XI--INDEMNIFICATION

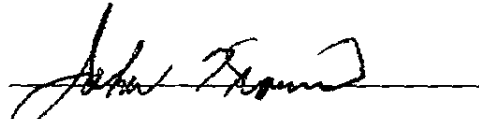

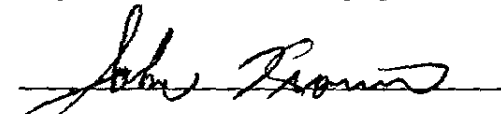
