**ARTICLES OF INCORPORATION
OF
THE FLOWER CAROUSEL, INC.**

The undersigned, being above the age of eighteen (18) years and competent to contract, and being a citizen and resident of the United States of America, for the purpose of organizing a for profit corporation under Chapter 607, F.S., hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation shall be **THE FLOWER CAROUSEL, INC.**

ARTICLE II - PRINCIPAL OFFICE

Principal place of business and mailing address is: 903 Hill Roost Road, Tallahassee, Florida 32312, in Leon County, Florida.

ARTICLE III - SPECIFIC PURPOSE; GENERAL POWERS

The primary purpose for which this Corporation is organized is to engage in the artificial and fresh flower business and any related services or activities. Such services shall be rendered only through officers, employees and agents of the Corporation. The Corporation shall have all the powers granted to corporations pursuant to Florida law, and nothing herein shall be construed as limiting or eliminating any such powers.

ARTICLE IV - SHARES

Number of Shares Authorized; Par Value. This Corporation is authorized to issue Ten Thousand (10,000) shares of common stock, each having a par value of One Dollar (\$1.00) per shares.

ARTICLE V - INITIAL OFFICERS AND/OR DIRECTORS

The initial president, secretary, treasurer and sole director is Kim F. Gerato

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this Corporation shall be located at 903 Hill Roost Road, Tallahassee, Florida, 32312. The initial registered agent of this Corporation at that address shall be Erasmo G. Gerato.
