

ARTICLES OF INCORPORATION

- I, the undersigned, **CHRISTINE ROBERTS**, do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.
- 1. NAME. The name of the corporation shall be COMPREHENSIVE REHAB SERVICES OF SOUTHWEST FLORIDA, INC. a Florida corporation.
