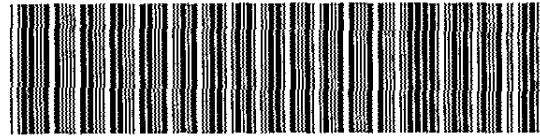

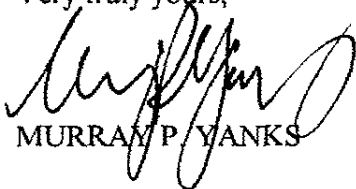

ARTICLES OF INCORPORATION

OF

BRIAN YANKS & ASSOCIATES, INC.

THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation, each a natural person competent to contract, hereby associates themselves together to form a corporation under the laws of the State of Florida.

ARTICLE ONE:

The name of this corporation is: Brian Yanks & Associates, Inc.

ARTICLE TWO:

A. The general nature of the business to be transacted by this corporation is any business authorized by law.

B. It is also authorized to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property and services, of every class, kind and description; except that it is not to conduct the business of a banking, safe deposit, insurance, surety express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

ARTICLE THREE:

The maximum number of share of stock that this corporation is authorized to have outstanding at any one time is One Thousand (\$1,000) shares of common stock with One and 00/100 (\$1.00) Dollar par value.

ARTICLE FOUR:

The amount of capital with which this corporation will begin business shall be no less than One hundred and 00/100 Dollars.

ARTICLE FIVE:

The corporation is to exist perpetually beginning upon receipt of these Articles by the Secretary of State of the State of Florida.

ARTICLE SIX:

The initial post office address of this corporation in the State of Florida is 2370 NE 135th Street, Apt. 302, Miami, Florida 33181.

ARTICLE SEVEN:

This corporation shall have 1 director(s) initially. The number of directors may be increased or diminished from time to time by by-laws adopted by the stockholders, but shall never be less than one.

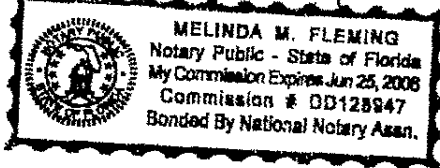
