

The undersigned hereby makes and subscribes these Articles of Incorporation intending to form a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I

The name of the corporation will be ILLA CYPH REPZ ENTERTAINMENT, INC.

The corporation may engage in any activity of business permitted under the laws of the United States and of the State of Florida. - (b) No contract or other transaction between the corporation and any other corporation, in the absence of fraud, shall be effected or invalidated by the fact that any one or more of the directors of the corporation is or are interested in, or is a director or officer or a director of directors, individually or jointly may be a party or parties to, or may be interested in any contract or transaction of the corporation, or in which the corporation is interested, and no contract, act or transaction, in absence of fraud, shall be affected or invalidated by, the fact that any director or directors of the corporation is a party or are parties to or interested in such contract, act or transaction, or in any way connected with such person who may become a director of the corporation is hereby relieved from any liability which might otherwise exist from his contraction with the corporation for the benefit of himself or any firm, association or corporation in which he may be in anywise interested.
