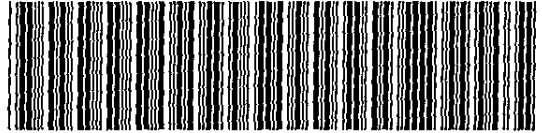

ARTICLE I CORPORATE NAME


ARTICLE XI AMENDMENT


