ARTICLES OF INCORPORATION
For

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is RCS CUSTOM WOODWORKING, INC. Principal place of business is 2320 NW 37 Way, Coconut Creek, FL 33066.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE
