ARTICLES OF INCORPORATION
OF

ARTICLE I - Name

The name of this corporation is Millenical Investment Properties, Inc.

ARTICLE II - Nature of Business

This corporation may engage in any activity of business permitted under the laws of the United States of America and of this State.

ARTICLE III - Capital Stock


ARTICLE XIII - Register Agent Acceptance
