FIRST: The name of the corporation shall be Nature's Natural Healing, Inc.



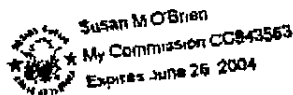


