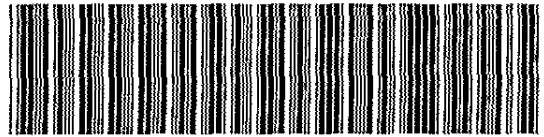

1.01 THE NAME OF THE CORPORATION IS AWY TRUCKIN INC.
