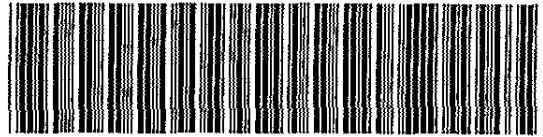

Name

The name of this corporation is:

A & B TOP & TEXTILE AND SUPPLIES, INC.

ARTICLE II

Duration

This corporation shall have perpetual existence.
