ARTICLES OF INCORPORATION

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporations for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I-NAME

The name of this corporation shall be JUST SAY I DO, INC.

ARTICLE II-PURPOSE

The corporation is being organized for the purpose of transacting any and all lawful business as permitted under the laws of the State of Florida.

ARTICLE III-CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 par value common stock, which shall be designated as "Common Shares". All of said stock shall be payable in cash, property (real or personal) or labor or services in lieu thereof at a just valuation to be fixed by the Board of Directors.

ARTICLE IV-VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Share.

ARTICLE V-TERM

This corporation shall commence existence on September 2, 2003 and shall exist perpetually thereafter unless sooner dissolved according to the law.

ARTICLE VI-PREEMPTIVE RIGHTS

Every shareholder, upon the sale of any new stock of this corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his/her pro-rata share thereof (as nearly as many be done without the issuance of fractional shares) at the price at which is offered to others.

ARTICLE VII-INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered agent's office of this corporation is 10220 S.W. 24th Court, Miramar, Florida 33025, and the initial registered agent is Marcia Williams.

ARTICLE VIII-PRINCIPAL PLACE OF BUSINESS

The principal place of business shall be 13402 S.W. 30th Court, Miramar, Florida 33027.

ARTICLE IX INITIAL BOARD OF DIRECTORS

The corporation shall have at least one director initially with the exact number of directors to be specified by the shareholders from time to time unless the shareholders shall, by a majority vote, determine that the corporation be managed by the shareholders. ARTICLE X

The corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law now existing or hereafter enacted.

ARTICLE XI

No contact or other transaction between this corporation, and any other corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the Directors of this corporation or pecuniarily or otherwise interested in, or are directors, or officers of such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact he or such firm is so interested shall be disclosed or shall have known to the Board of Directors or a majority thereof, any director of this corporation who is also director or any officer of such corporation, or is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall authorized any such contact or transaction with like force and effect, as if he were not such director or officer of such other corporation, or no so interested.

ARTICLE XII

The private property of the stockholders shall not be subject to the payment of the corporate debts to any extent whatsoever. The corporation shall have the first lien on the shares of its stockholders *and upon the dividends due them for any indebtedness of such stockholders to the corporation.*
