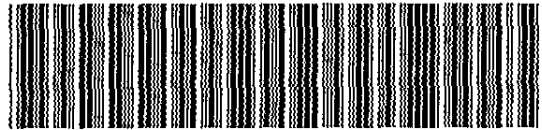

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.


## **ARTICLE X INDEMNIFICATION**


