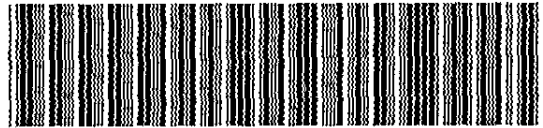

**ARTICLES OF INCORPORATION
OF
PROFESSIONAL CARE SERVICES OF SOUTH FLORIDA, INC.**

The undersigned Incorporator named herein does hereby subscribe to and file these Articles of Incorporation for the purposes of organizing a corporation under the Florida Business Corporation Act.

ARTICLE I

The name of the corporation is Professional Care Services of South Florida, Inc.

ARTICLE II

The address of the corporation is 16450 N.E. 7th Avenue, North Miami Beach, FL 33162.

ARTICLE III

The corporation shall exist perpetually. The corporate existence shall commence as of the filing of the Articles of Incorporation.

ARTICLE IV

The Corporation is organized for the purpose of transacting any and all lawful business for which a corporation may be incorporated under the Florida Business Corporation Act.

**ARTICLE V
CAPITAL STOCK**

The corporation is authorized to have outstanding one class of stock designated as common stock. The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.

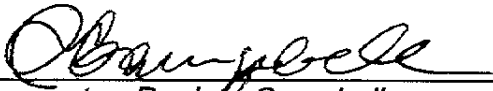
**ARTICLE X

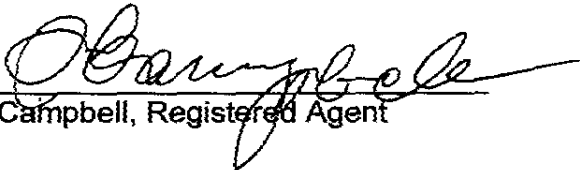
