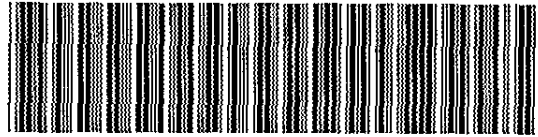


ARTICLE VII--AMENDMENT
