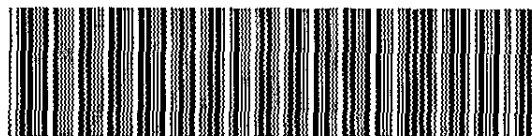

ARTICLE V PRINCIPAL PLACE OF BUSINESS

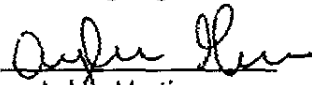

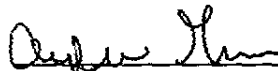
ARTICLE IX
