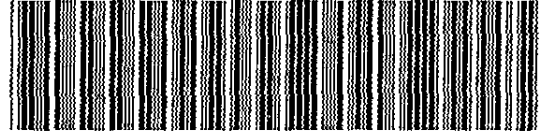

ARTICLE ONE

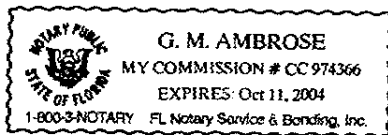
