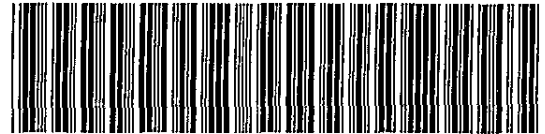

**ARTICLES OF INCORPORATION  
OF  
STERLING & ASSOCIATES, LAW FIRM, INC.**

**THE UNDERSIGNED**, natural person(s) of legal age, acting as incorporator(s) of a corporation Under the laws of the State of Florida, adopt the following Article of Incorporation for such Corporation.

**ARTICLE I - NAME**

The name of the corporation is **STERLING & ASSOCIATES LAW FIRM, INC.**

**ARTICLE II - DURATION**

The period of its duration is perpetual.

**ARTICLE III - NATURE OF BUSINESS**

The purpose(s) for which this corporation is organized is" To establish a Law firm Business To practice Law in the State "consistent with general service to the public and the legal industry". "And any other lawful business activity for which corporation may be incorporated under Chapter 607 of the Florida Statutes".

**ARTICLE IV - CAPITAL STOCK**
