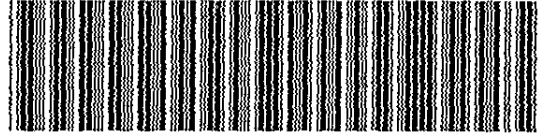

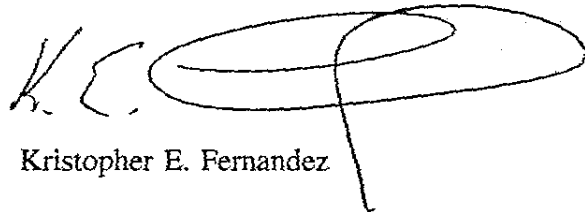

The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a for - profit corporation (the "Corporation") under the laws of the State of Florida, as follows:

1. NAME

EFFECTIVE DATE
9-11-03

The name of the Corporation is: Corcoran Design Group, Inc.

2. TERM OF EXISTENCE

The date when the corporate existence shall commence shall be September 11, 2003, and the Corporation shall have perpetual existence thereafter.

3. PURPOSE

The purpose for which the Corporation is organized is to transact any and all business for which a corporation may be incorporated under Florida laws.

4. CAPITAL STOCK

The initial Board of Directors shall have two members whose name and address is as follows:

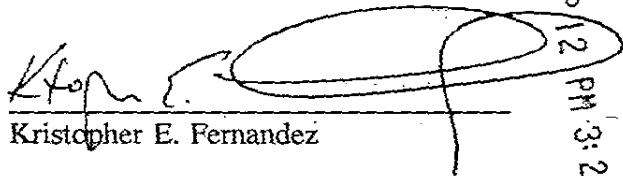

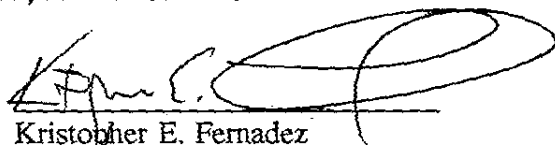
