

OF

**The undersigned does hereby form a corporation under Chapter 607 of the laws of the State of Florida.**

**ARTICLE I. -- NAME AND ADDRESS**

**The name of the corporation shall be: NAV-QUEST, INC.**

**ARTICLE II. -- PRINCIPAL OFFICE**




