NAME & ADDRESS:**

Treasury shares may be disposed of by the corporation for such consideration may be determined from time to time by the board of directors. The consideration for the issuance of shares or for the disposal of treasury shares may be paid, in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation. POWERS


This corporation shall have all powers necessary or convenient to effect its purpose as enumerated in the Florida General Corporation Act.






