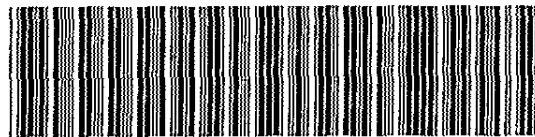



The incorporator, desiring to form a corporation for profit under the General Corporation Law of Florida, certifies:

ARTICLE ONE
NAME

The name of the corporation is PROTECTOR PEST CONTROL INC.

ARTICLE TWO
DURATION AND PURPOSE

This corporation shall have perpetual existence. The general purpose for which the corporation is formed is to engage in any or all lawful acts or activity for which corporations may be incorporated under the Florida General Corporations Act.

ARTICLE THREE
PRINCIPAL OFFICE AND MAILING ADDRESS




