ARTICLES OF INCORPORATION OF DPMB, INC.

The undersigned incorporator of this Corporation under Chapter 607, Florida Statutes, as amended, adopts the following Articles of Incorporation.

ARTICLE!

The name of this Corporation is: DPMB, INC.

ARTICLE II

The principal place of business of this Corporation shall be 240 71st Street, Miami Beach, Florida 33141.
