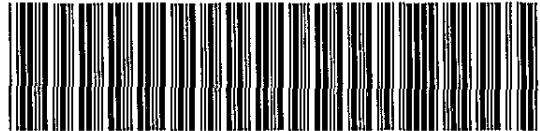

Article XIII – Amendment



Article – Fourteen




