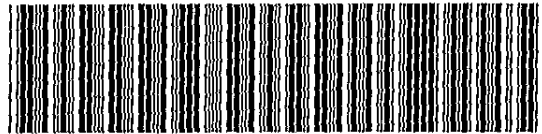

OF
