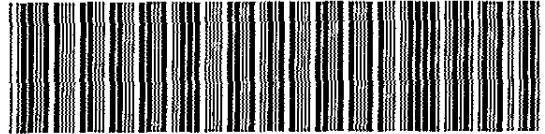

The undersigned hereby associate for the purpose of becoming incorporated under the laws of the State of Florida, under the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be **"Pro-Athlete Services, Inc."**

**ARTICLE II**

This corporation shall have perpetual existence.

**ARTICLE III**

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV**

The total authorized capital stock of this corporation shall be fifty thousand (50,000) shares of common stock at a par value of ten cents (\$.10) per share, fully paid and non-assessable.

**ARTICLE V**


