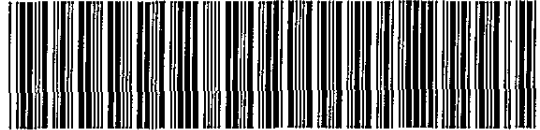

ARTICLE I


