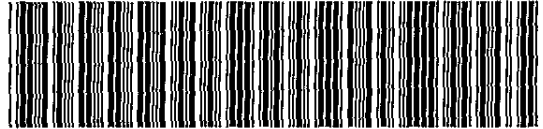

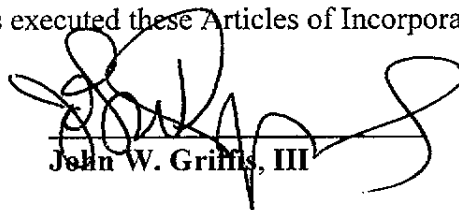

BY THESE ARTICLES OF INCORPORATION the incorporator forms a business corporation for profit under Florida law.

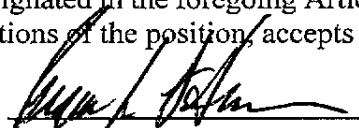
1. NAME. The name of the corporation is **Automation and Control Solutions, Inc.**
