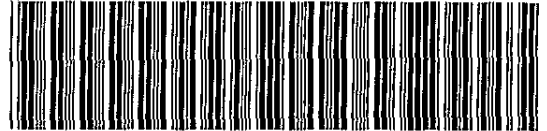



The undersigned incorporator(s), for the purpose of forming a corporation under the Florida business corporation act, hereby adopt(s) the following articles of Incorporation.

**ARTICLE I - NAME**

The name of this corporation shall be: **ASHMAN AND THORNTON ENTERPRISE, INC.**

**ARTICLE II - COMMENCEMENT OF EXISTENCE**

The existence of the corporation shall commence on the date of subscription and acknowledgment of these Articles of Incorporation.

**ARTICLE III - PRINCIPAL OFFICE**

The initial principal place of business and mailing address of this corporation shall be:
