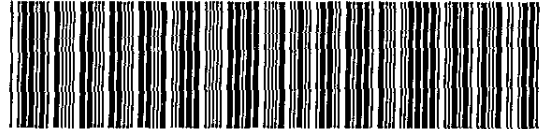



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be VOLITION, INC.

ARTICLE II LOCATION

ARTICLE III NATURE OF BUSINESS

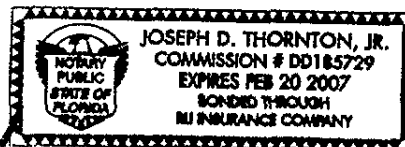


