The undersigned natural person, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Chapter 607, Florida General Corporation Act and Chapter 621, Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation:
