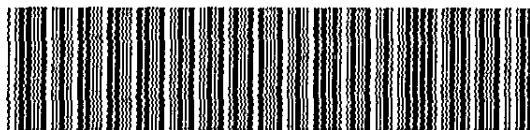

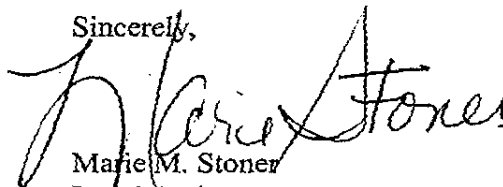

ARTICLES OF INCORPORATION
OF

The undersigned natural person, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Chapter 607, Florida General Corporation Act and Chapter 621, Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be JOHN C. COLLIAS, D.M.D., P.A.

ARTICLE II - PURPOSE

The purpose of the corporation is to engage in the practice of dentistry and the rendition of medical services as well as to engage in any other business permitted under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

The corporation shall be authorized to issue One Thousand shares (1,000.00) of common stock at \$1.00 per share par value and shall be issued only to a duly licensed professional in good standing who has paid consideration in lawful money, property, labor or services.

ARTICLE IV - PRINCIPAL OFFICE

ARTICLE V - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VI - INCORPORATOR

The name and address of the incorporator is John C. Collias, 10443 Gulf Beach Highway, #4, Pensacola, Florida 32507.

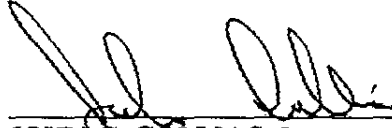
ARTICLE VII - BOARD OF DIRECTORS
