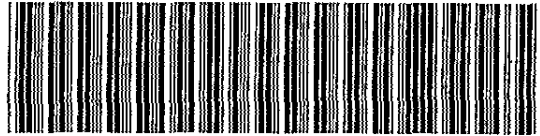

ARTICLES OF INCORPORATION  
OF

**DONALD F. BADKE CONSTRUCTION CORPORATION**

ARTICLE I. NAME. The name of the Corporation is Donald F. Badke Construction Corporation.

ARTICLE II. DURATION. This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE. This Corporation is organized to transact and carry on any activity or business permitted under the laws of the United States and the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK. This Corporation is authorized to issue 1,000 shares of one-dollar (\$1.00) par value common stock.

ARTICLE V. MANAGEMENT.

- A. Pursuant to the provisions of Section 607.111, Florida Statutes, as the same exists upon the adoption of these Articles of Incorporation, the business of this Corporation may be managed by the shareholders of the Corporation, rather than by a Board of Directors.
- B. Should the shareholders of the Corporation so elect, they may by resolution and bylaw establish a Board of Directors to manage the business of this Corporation. In such event, the shareholders shall prescribe the duties, functions, and methods of operation of such Board of Directors with particularity and in appropriate bylaws.


ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT. The street address and mailing address of the initial registered office of this Corporation is 144 East Fredrick Avenue, Lake Mary, Florida, 32746. The principal street address and mailing address of the Corporation is 144 East Fredrick Avenue, Lake Mary, Florida, 32746. The name and address of the initial registered agent of this Corporation is Donald F. Badke, 144 East Fredrick Avenue, Lake Mary, Florida, 32746.

ARTICLE VII. INCORPORATOR. The name and address of the person signing these Articles of Incorporation is Donald F. Badke, 144 East Fredrick Avenue, Lake Mary, Florida, 32746.

ARTICLE VIII. PRE-EMPTIVE RIGHTS. Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the same price per share at which shares are offered to others.

ARTICLE IX. AMENDMENTS. These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the shareholders representing a majority of the outstanding shares of the Corporation entitled to vote thereon.


