ELBA MENDIZABAL, the undersigned, being of the age of eighteen (18) years or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

1. The name of the Corporation shall be: LITTLE PARADISE CORP.
2. The number of shares the corporation is authorized to issue shall be 500 shares all of one class designated as common stock, at \$ 1.00 per value.
3. The street address and county of the initial principal office of the corporation is 11319 SW 114<sup>TH</sup> Circle Terrace Miami, Fl. 33176, Miami-Dade County and the name of the initial registered agent at this address is: Elba Mendizabal.
4. The number of directors constituting the initial Board of Directors shall be two directors and the names and addresses of the persons whom are to serve as directors until the first meeting of shareholders or until their successors are elected and qualified are:

5. The corporation elects to have preemptive rights. (continued on page 2)


