The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

#### ARTICLE I

#### NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is JTP Florida Films, Inc.
