ARTICLES OF INCORPORATION

OF

GEORGIA BLUE CORPORATION

ARTICLE I: NAME

The name of the corporation is **GEORGIA BLUE CORPORATION** (hereinafter called the "Corporation").

ARTICLE II: PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under The Florida Business Corporation Act of the State of Florida.

ARTICLE III: CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 10,000 shares of Common Stock, with a par value of \$1.00 per share.

Shares of capital stock of the Corporation which have been issued and subsequently acquired by the Corporation shall constitute issued but not outstanding shares of the same class and series, until cancelled or disposed of (whether by resale or otherwise) by the Corporation. If the Board of Directors cancels any such shares, the cancelled shares shall constitute authorized and unissued shares of the same class and shall be undesignated as to series.
