

ARTICLES OF INCORPORATION
OF

The undersigned does hereby sign this Certificate of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I
(Name)

The name of the corporation shall be: BIKINI BLISS, INC.

ARTICLE II
(Duration)

The corporation shall have perpetual existence.

(Purpose)

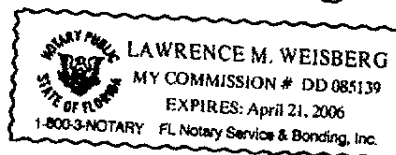
