# ARTICLES OF INCORPORATION of WHITE-ROSE INSTALLATION, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporations Act, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation, which shall hereinafter be referred to as the "Corporation" shall be: WHITE-ROSE INSTALLATION, INC.

#### **ARTICLE II**

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The Bylaws may provide that every stockholder is not to have the right to so purchase.
